REQUEST FOR CONVERSION

1. t/a Town Hall Restaurant and Liquors, see letter dated December 28, 2023, requesting for the conversion of the Class B+ License to a Class A, Beer, Wine, and Liquor License during the renewal period between February 1, 2024, through March 1, 2024.

Represented by Robert Kim, Esquire.

Mr. Kim is the attorney of record, however his colleague Michael Brown participated in the hearing.

Town Hall Restaurant and Liquors has been operating as a Beer, Wine, and Liquor store and restaurant in College Park.

Ms. Tandon has been the sole licensee for seven years.

Mr. Brown states the purpose in converting this license to a Class A is to move the location to Collington Plaza in Bowie, Maryland. The lease has been signed for the new location for twenty years. My client understands they're waving their off-sale privilege license. There are no other Class A licenses within a one-mile radius.

Commissioner Camacho makes a motion to convert the license from a Class BL+ to a Class A license for t/a Town Hall Restaurant and Liquors, seconded by Commissioner Norman.

After Board vote, the motion carries.

Harshadkumar Patel, Managing Member/Authorized Person, for a Class A, Beer, Wine and Liquor for the use of Eastover Wine & Spirits, LLC, t/a Apollo Wine & Spirits, 4585 Telfair Blvd, Suite #300A, Camp Springs, 20746, transfer from Eastover Wine & Spirits, LLC, t/a Eastover Liquors, 4909 Indian Head Highway, Oxon Hill, 20745, Harshadkumar Patel, Member-Manager.

Mr. Patel has been the sole licensee of Eastover Wine and Spirits, LLC. for seven years. He previously owned a liquor store in Anne Arundel County and has only received one violation during his twenty-year tenure as a licensee.

Representative of Mr. Schwartz, Susan Vogel introduced Peter Schwartz, who is the landlord of the entity that is restaurant row. He testified in favor of the transfer of this location.

Mr. Carter states there are no off-sale establishments within a one-mile radius of Restaurant Row. Mr. Patel will be spending more than half a million dollars on the establishment.

Mr. Carter asked the standard questions typically used to qualify the transfer of the license. Including what are the six acceptable forms of I.D., and the legal age to purchase and sell alcohol. The applicant was able to answer each question.

Commissioner Camacho makes a motion to approve the transfer of the Class A license

for t/a Apollo Wine & Spirits, seconded by Commissioner Norman.

After Board vote, the motion carries.

Copies of **Mr. Parsana's** and **Mr. Kaswala's** Alcohol Awareness certificates have been submitted to the Board.

Commissioner Camacho makes a motion to approve the transfer of the Class A license for t/a Maxey Liquors, seconded by **Commissioner Norman.**

Mr. Patel and all managers of King Kong Restaurant are Alcohol Awareness certified. There will be no changes to the mode of operation for the first two years.

King Kong Restaurant will not be accepting vertical ID's or the real ID on cell phones. **Ms. Carter** asked the standard questions typically used to qualify the transfer of the license. Including what are the six acceptable forms of I.D., and the legal age to purchase and sell alcohol. The applicant was able to answer each question.

Commissioner Camacho makes a motion to approve the transfer of the Class B License for t/a King Kong Restaurant, seconded by **Commissioner Norman.**
