- WMATA plans on eliminating eliminate 67 bus lines, 22 of which operate within Prince George's county. This will disrupt the daily commute of thousands of residents who rely on these routes.
- The entire rail system could shut down as early as 100'clock pm. If these cuts go into effect, it's going to affect approximately 14,000 Prince Georgians.
- The Office of Community Relations and Common Ownership Communities unit provided a briefing of the unit's activities to the Planning Housing and Economic Development Committee on February 15, 2024. During the Briefing Commission reappointments, as well as new appointments, were presented to the County Council. The new appointments were confirmed by the County Council on Tuesday, February 27, 2024.
