# **New Business**

Commissioner Smith provided a PowerPoint presentation on Annual Open Virtual/ In person Meetings.

### **Questions/Concerns**

- Q: If I have a meeting which may or may not reach quorum, and I must reserve a room where I am having the meeting 15 days out what should I do.
- A: The meeting can be done virtually as an alternative or the next meeting notice can be sent out 10 days before the next meeting if the first meeting doesn't meet quorum.
- **Q**: Opened several cases with the Office of Attorney General about Board members not following the rules and regulations of elections. What are the consequences of doing this?
- A: We must pick and choose what actions to take when dealing with these situations. There are a lot of situations that come but the Office of Attorney General is low on staff to help assist with issues as quickly as they would like to. Commissioner Holmes is working towards fixing this issue and asks that you be patient with him as he does so.
- **Q:** Feels as though her HOA Board at Mellow brook is abusing their power with parking passes when residents do not fix issues in their community.
- A: We don't help get rid of people in position on the Board, but we help assist to make sure they are following the bylaws and regulations. We can give you the Office of Attorney General number and you can put in your concern to them.
- **Q**: I wanted to know how long it will take to get a response on concerns that are going on in my home, and how can we help make COC more effective in Prince Georges County
- A: Your documents are still in review so we can get all the information you need for your concern. We will try and get you a response this week but we want to make sure we have all the best options for your concern since a lot of the options have timelines so we will be in contact with you. 2024 legislation is being put in motion to help concerns for Prince Georges County Government COC to help provide better assistance. Won't be available to the public eye until January.

- **Q:** Can you confirm that committee meetings are also subject to open meetings act and is it possible that these power point slides can be attached to the EDvantage training?
- A: Yes, they are. We will send you information via email regarding power point slides to have so you can be well informed and your community.
- **Q**: We just finished going through our 2024 budget proposal and we noticed that our insurance has gone off the charts this year and wanted to know if there is any help, we can get with this?
- A: Insurance across the United States has been increased. There's not much we can do about, but I asked in the new legislation to help assist HOAs with some maintenance with this.
- **Q**: I am paying my condo association fee at Tribeca but now I have a letter coming in to pay an HOA fee. So, do I pay my condo association fee to the HOA? What is the difference?
- A: Call the management company and your HOA to see what the issue is. You can also contact Ray who is the Attorney for Tribeca HOA instead of the management company to get better assistance.
