CHARGES:

Allegedly on April 26, 2022, Prince George's County Animal Services received a report of 3 dogs that are often running at large and chasing people from the 13205 Sunfield Terrace address. Prince George's County received five complaints from September 3, 2021, to April 26, 2022, for multiple dogs running loose from this address. This is a violation of Section 3-131 'Manner of Keeping Animals; Prohibition of Nuisances'; Section 3-132 'Public Nuisance Conditions'; Section 3-135 'Animals at Large Prohibited'; Section 3-142 'Irresponsible Pet Owner'; Section 3-182 'Potentially Dangerous Animal'; and Section 3-186 'Vaccination of ferrets, dogs and cats' of the Prince George's County Code.

CHARGES:

Allegedly on August 20, 2022, Edin Barrientos' dog 'Max' was running at large and attacked Mr. Ashby-King's dog. The attack resulted in injuries to "Max" hind quarter and rear paw. This is a violation of Section 3-131 'Manner of Keeping Animals; Prohibition of Nuisances'; Section 3-132 'Public Nuisance Conditions'; Section 3-135 'Animals at Large Prohibited'; Section 3-142 'Irresponsible Pet Owner'; Section 3-145 'Ferret, Dog and Cat License'; Section 3-182 'Potentially Dangerous Animal'; and Section 3-186 'Vaccination of ferrets, dogs and cats' of the Prince George's County Code.

CITY OF COLLEGE PARK

v.

WANDRA PERKINS

CHARGES:

Allegedly on February 5, 2023, Wanda Perkins' dog "Nikko" was running at large and attacked a dog named "Zoey" in front of 7304 Radcliffe Drive in College Park. This is a violation of Section 3-131 'Manner of Keeping Animals; Prohibition of Nuisances'; Section 3-135 'Animals at Large Prohibited'; Section 3-136 ' Dangerous Animal'; 3-142 'Irresponsible Pet Owner'; Section 3-182 'Potentially Dangerous Animal'; and Section 3-145 'Ferret, Dog and Cat License' of the Prince George's County Code.

GENERAL RULES

Cases shall be called in the order in which they appear on the docket. The Commission may consider cases out of the order presented on the written docket, at the discretion of the Chairperson, to promote efficiency and as an accommodation to the parties involved.

All attempts will be made to allot time fairly to opposing parties and witnesses. However, all persons testifying under oath shall speak only after receiving recognition and consent of the Chairperson.

Hearings are open to the public. Verbal and physical disruptions from the public are prohibited. Members of the public are required to comply with rules, directives, and orders of the Commission.
