I am pleased that you have agreed to accept the role as Chairman of the Prince George's County Local Development Council (PGCLDC). Thank you for your willingness to serve in this capacity.

Enclosed is the proposed Prince George's County Multi-Year Spending Plan for FY 2017 through FY 2020, and the following three years. Pursuant to Prince George's County, Subtitle 10, Finance and Taxation, Section 10-309.02 and State Government Article, Section 9-1A-31, the County shall develop, in consultation with the Prince George's County Local Development Council (PGCLDC), a multi-year plan for the expenditure of the local impact grant funds for services and improvements, primarily in communities within the immediate proximity of the gaming facility located in Prince George's County. This correspondence will constitute my submission of the spending plan to the PGCLDC.


It is unfortunate that there was not an opportunity to present and discuss this plan with the PGCLDC during the recent meeting held on February 3rd. Consequently, it will be presented at the next PGCLDC meeting which will be held within the next few weeks.

In accordance with the Prince George's County Code, the County Executive's recommendations on the multi-year spending plan are transmitted to the County Council for their feedback. Comments from the County Council are then included as part of the transmittal of the Multi-Year Spending Plan to the PGCLDC. The comments from the County Council on this spending plan have been received and have been incorporated into the attached document. Most notably, there is concurrence with the County Council that any unspent funds will roll over to the next fiscal year and will follow the same process as this year's plan.
