



CONTEST/PROMOTIONS/SWEEPSTAKES RULES AND REGULATIONS

NO PURCHASE NECESSARY TO WIN. OPEN TO ALL LEGAL RESIDENTS OF PRINCE GEORGE'S COUNTY AGE APPROPRIATE.

- 1. Eligibility: Giveaway (the "Giveaway") is open only to any Prince George's County resident (proof of residency will be required). Officials of Prince George's County and their respective affiliates, subsidiaries, advertising and promotion agencies, suppliers are not eligible to participate. Pursuant to Prince George's County Code Sec.2-291(a) (10), the term "Official" means an "elected official, an employee of the County, or a person appointed to or employed by the County, or any County agency, board, commission, or similar entity whether or not paid in whole or in part with County funds and whether or not compensated."
- 2. Agreement to Rules: By participating, you agree to be fully unconditionally bound by these Rules, and you represent and warrant that you meet the eligibility requirements set forth herein.
- 3. Giveaway Period: June 1, 2020 August 31, 2020.
- 4. How to Enter: Join the Prince George's Office of Community Relations (OCR) at any of the signature 100 Events of Summer community activities to enter.
- 5. Prizes: Prizes have been pre-determined and donated for the sole purposes of use and distribution to the community. The prize is nontransferable. No substitution of prize or transfer/assignment of prize to others or request for the cash equivalent by winners is permitted. If the selected winner cannot be contacted, is ineligible, fails to claim the prize within 15 calendar days from the time award notification was sent, or fails to timely return a completed and executed declaration and release as required, prize may be forfeited, and an alternate winner selected.
