**OFFICIAL NOTICE OF**  
**CLASS B LICENSE RENEWAL**

1. **RENEWALS ARE DUE APRIL 1<sup>ST</sup>** – Class B licenses expires **May 31<sup>st</sup>**. **Applications will not be accepted after the close of business Monday April 2<sup>nd</sup>**.
2. **BACKGROUND CHECK** - Pursuant to Section 26-1806 of the Alcoholic Beverage Article of the Annotated Code of Maryland, every licensee and stockholder must receive criminal history check in order to renew any Alcoholic Beverage License.
3. **CORPORATIONS/LLC** – The Renewal Application **MUST BE ACCOMPANIED BY A CERTIFICATE OF GOOD STANDING**, which may be obtained, via US mail, from the State Department of Assessments and Taxation, State Office Building, 301 West Preston Street, Room 801, Baltimore, Maryland 21201. A remittance of \$20.00 must accompany your request for the Certificate. Alternatively you can obtain a certificate by walk-in or printed from the Internet for a \$40.00 fee. The website is [www.dat.state.md.us](http://www.dat.state.md.us) - follow the directions to obtain a “certificate of status”. For additional information please contact 410-767-1340.
4. **FULLY COMPLETED APPLICATIONS** – Make sure all questions are answered fully and all signatures are notarized. Incomplete applications will not be accepted.
5. **PAYMENT OF RENEWAL FEES** – Applications must be accompanied by a Money Order, Certified Check or Cashier’s Check, made payable to Prince George’s County. Credit Card payments are accepted online upon request. **NO CASH OR PERSONAL CHECKS WILL BE ACCEPTED.**

6. **TAXES:** Pursuant to Section 26-1807 of the Alcoholic Beverage Article of the Annotated Code of Maryland, ALL TAXES DUE to the State of Maryland, Prince George's County and any municipality must be PAID or a payment plan must be in place in order to renew any Alcoholic Beverage License.
7. **AFFIDAVITS** - Pursuant to Rule 45 of the Rules and Regulations each licensee and/or stockholder must file an Affidavit.
8. **COMPLIANCE WITH ALCOHOL AWARENESS** – Renewal applications must be accompanied by a Certificate of Compliance with Alcohol Awareness Training as provided for in Section 3-504 of the Alcoholic Beverage Article of the Annotated Code of Maryland.
