

FEDERAL PROGRAMS

Federal programs consist of various program activities undertaken with Federal Community Development Block Grant (CDBG) funds in accordance with CB-101-1981 and the annual Community Development Program adopted by the County Council and approved by the U.S. Department of Housing and Urban Development. The details of Federal programs can be found in the above Plan and Program documents to be adopted by Council resolution prior to the commencement of the program year.

The annual entitlement amounts for program support are based on a multi-factor formula, and the plan and program are designed to achieve neighborhood revitalization, economic development and job-creation objectives primarily within low-and moderate-income areas of the County. Each of the capital construction projects included in the annual Community Development Program is incorporated into the CIP by inclusion of the Federal programs section.
