TRANSIT ORIENTED SERVICES

- At DPW&T, the Office of Transportation continues to respond to requests for Call-A-Bus services and Call-A-Cab vouchers. Any eligible County resident can call 301-499-8603 to schedule a trip through the County's Call-A-Bus program, Monday through Friday between 8:30am to 4:00pm. - The Taxi division has temporarily suspended in-person transactions associated with processing new and renewal applications for licenses and medallions. Expired licenses and medallions will continue to be valid through extended terms, as outlined in official correspondence.
