Animal Services Violation Notices #99409, #99412, #99413, #99410, #99411, and #99414 for violations of Section 3-135 'Animals at Large Prohibited' and Section 3-145 'Ferret, Dog, and Cat Licenses' of the Prince George's County Code.

#### **CHARGES:**

Allegedly Joseph Harley has failed to comply with orders of the Commission for Animal Control. Mr. Harley was brought before the Commission for Animal Control on May 22, 2019 for a vicious dog hearing in reference to his dogs running at large attacking and killing Mr. Lantz's cat. As a result, 'Missy', a white and brown American bulldog, and 'Pinky', a brown and white American bulldog were declared vicious. Mr. Harley failed to comply with the vicious dog restrictions and on December 5, 2019, these two dogs were allegedly running at large and attacked Mrs. Westhall's dog, resulting in its death. This is in violation of Section 3-125 'Interference with Impounding Animals', Section 3-131 'Manner of Keeping Animals: Prohibition of Nuisances', Section 3-136 'Vicious Animals', Section 3-137(h) 'Vicious Animal Restrictions' and Section 3-145 'Ferret, Dog, and Cat Licenses' of the Prince George's County Code.

### No. 71-19 MALEIK BROWN

v.

PRINCE GEORGE'S COUNTY, MD

#### **PETITION:**

For return of custody of six, one month old Pit Bull puppies, three male and three female. Allegedly Maleik Brown was found in violation of Section 3-131 'Manner of Keeping Animals-Adequate Feed', Section 3-131 'Manner of Keeping Animals-Adequate Water', Section 3-131 'Manner of Keeping Animals-Adequate Shelter that is Properly Cleaned', Section 3-131 'Manner of Keeping Animals-

Adequate Care, Proper and Appropriate Treatment', Section 3-131 'Manner of Keeping Animals-Adequate veterinary care and Veterinary care when needed to Prevent Suffering or Disease Control', Section 3-180 'Cruelty and Neglect', and Section 3-185.01 'Pit Bull Terriers' of the Prince George's County Code.

## **GENERAL RULES**

Cases shall be called in the order in which they appear on the docket. The Commission may consider cases out of the order presented on the written docket, at the discretion of the Chairperson, to promote efficiency and as an accommodation to the parties involved.

All attempts will be made to allot time fairly to opposing parties and witnesses. However, all persons testifying under oath shall speak only after receiving recognition and consent of the Chairperson.

Hearings are open to the public. Verbal and physical disruptions from the public are prohibited. Members of the public are required to comply with rules, directives, and orders of the Commission.
