No. 16-20 VA PRINCE GEORGE'S COUNTY, MD v.

DARNEL MCINTOSH

CHARGES:

Allegedly Darnel McIntosh's dog, a three-year-old, male, tan Golden Retriever mix named 'Odie' was running at large and attacked Ms. Joy Brown's dog, a oneyear-old, female, black and tan Pomeranian named 'Dolce'. Your dog shows the propensity to be dangerous by virtue of the alleged attack. This is in violation of Section 3-131 'Manner of Keeping Animals; Prohibition of Nuisances', Section 3-135 'Animals at Large Prohibited', Section 3-136 'Dangerous Animals', and Section 3-142 'Irresponsible Owners' of the Prince George's County Code.

No. 46-20 VA PRINCE GEORGE'S COUNTY, MD v. BRENDA RODRIGUEZ

CHARGES:

Allegedly Brenda Rodriguez's dog, a gray and white, male Siberian Husky named 'Simba' was running at large when he attacked a Ms. Angel Gorden-Nelson's dog, resulting in her dog's death. Your dog shows the propensity to be dangerous by virtue of the alleged attack. This is in violation of Section 3-131 'Manner of Keeping Animals; Prohibition of Nuisances', Section 3-135 'Animals at Large Prohibited', Section 3-136 'Dangerous Animals', Section 3-142 'Irresponsible Pet Owner', Section 3-145 'Dog, Cat, and Ferret License', and Section 3-186 'Vaccination of Ferrets, Dogs, and Cats' of the Prince George's County Code.

CHARGES:

Allegedly Andre Hardy's dogs, a gray and white, male Pit Bull Terrier named 'Titus' and a tan and white, female Pit Bull Terrier named 'Lola' were running at large when they attacked a Ms. Erin Canty's dog, resulting in her dog's death. Your dogs show the propensity to be dangerous by virtue of the alleged attack. This is in violation of Section 3-131 'Manner of Keeping Animals; Prohibition of Nuisances', Section 3-135 'Animals at Large Prohibited', Section 3-136 'Dangerous Animals', Section 3-142 'Irresponsible Pet Owner', Section 3-185.01 'Pit Bull Terriers', and Section 3-186 'Vaccination of Ferrets, Dogs, and Cats' of the Prince George's County Code.

No. 48-20 VA PRINCE GEORGE'S COUNTY, MD

v.

ANGELA BAILEY

CHARGES:

Allegedly Angela Bailey's dog, a brindle and white, female Pit Bull Terrier named 'Mystic' was tethered in Bailey's backyard when 8-year-old Christopher Deleon rode a motorized bike in the yard. This startled the dog, resulting in Christopher being attacked. This is in violation of Section 3-185.01 'Pit Bull Terriers' of the Prince George's County Code.

GENERAL RULES

Cases shall be called in the order in which they appear on the docket. The Commission may consider cases out of the order presented on the written docket, at the discretion of the Chairperson, to promote efficiency and as an accommodation to the parties involved.

All attempts will be made to allot time fairly to opposing parties and witnesses. However, all persons testifying under oath shall speak only after receiving recognition and consent of the Chairperson.

Hearings are open to the public. Verbal and physical disruptions from the public are prohibited. Members of the public are required to comply with rules, directives, and orders of the Commission.
