CHARGES:

Allegedly, Ms. Blanca Duran's dog, a black and brown male Rottweiler named 'Doro', has been allowed to repeatedly cause a disturbance of the comfort or repose of any person or neighborhood. "Doro" has been at large numerous times and has attempted to attack a human twice and has made unwanted contact with a dog, causing injury. This is in violation of Section 3-131 'Manner of Keeping Animals; Prohibition of Nuisance', Section 3-135 'Animals at Large Prohibited', and Section 3-136 'Vicious Animal' of the Prince George's County Code.

CHARGES:

Allegedly Wesley Musser's dog, a spayed female black with tan and white Austrian Shepherd named 'Sookie', was running at large when she bit a Ms. Carrie Quigley, who was jogging, on her left leg. 'Sookie' has a history of running at large and two other documented instances of biting. In 2015, she attacked a Mr. Bob Kanyuck while he was speaking with Mrs. Musser. On 6/18/16, she attacked a Mr. William Gorgan and his wound became infected. Your dog shows the propensity to be vicious by virtue of the alleged attacks. This is in violation of Section 3-131 'Manner of Keeping Animals; Prohibition of Nuisances', Section 3-135 'Animals at Large Prohibited', Section 3-136 'Vicious Animals', Section 3-145 'Ferret, Dog and Cat Licenses', and Section 3-186 'Vaccination of Ferrets, Dogs, and Cats' of the Prince George's County Code.

GENERAL RULES

Cases shall be called in the order in which they appear on the docket. The Commission may consider cases out of the order presented on the written docket, at the discretion of the Chairperson, to promote efficiency and as an accommodation to the parties involved.

All attempts will be made to allot time fairly to opposing parties and witnesses. However, all persons testifying under oath shall speak only after receiving recognition and consent of the Chairperson.

Hearings are open to the public. Verbal and physical disruptions from the public are prohibited. Members of the public are required to comply with rules, directives, and orders of the Commission.
