Niukang Asong stated that he is a resident of Middle River; that he is the co-owner of the business; that he is the managing partner; that this is an upscale West African restaurant; that he is catering to young professionals; that they have a menu; that the menu is unique; that there are not any restaurants like theirs in the area; that they will offer mostly sit down; that they have good spicy African food; that they have already invested \$85,000 and anticipate spending \$120,000 on the restaurant; that their funds was personal money; that they do not have any loans; that they hired a chef; that the people are happy about them opening; that they have 29 letters of support; that there are no other restaurant like this in Beltsville with West African food; that they will feature food from Cameroon; that both of the owners will be onsite; that his background is finance and human resources; that they have previously worked with the owners of a restaurant in Silver Spring; that his partners family had a restaurant; that he understands the responsibility to comply with the laws; that he is alcohol awareness certified; that a person must be 21 to purchase and 18 to sell alcoholic beverages; he stated the five acceptable forms of identification; that everyone appearing under 35 will be carded; that they will not accept vertical identification; that they emphasize food at the restaurant; that he has not been convicted of a crimes; that there are no changes to the application; that the restaurant is not open; that they plan to open in two to three weeks; that they will have eight tables; that the menu has four items.

<u>Valery Azeh</u> stated that he is a resident of Lanham; that he has been a resident of Maryland for nine years; that he is owner of the business; that he does not have an interest in any other business with an alcoholic beverage license; that there are no changes to the application; that he will work as needed; that he is familiar with the rules and regulations; that he agrees with the policies; that they will not offer entertainment.

are over 2000 people from West African and West Indies in the area; that the area is in the revitalization district; that she has had a lot of growth; that she is the general manager; that she is alcohol awareness certified; that she has read the rules and regulations; that she understands the rules and regulations; that you must be 18 to sell and 21 to purchase alcoholic beverages; she stated the five acceptable forms of identification; that she will train the employees; that they have 100% identification checks; that they have plans to offer entertainment; that they will add entertainment in the next 5-6 months; that they want a DJ to plan African must for the customers; that they will talk to the community about volunteering; that they had a violation in December 2017; that they have a sign above the window; that the violation was not related to sales of alcoholic beverages; that the violation was related to entertainment; that they want entertainment; that they want a DJ.

<u>Walter Adino</u> stated that he is a resident of Laurel; that he worked at Double T since 1993; that this is a dream come true; that Mr. Korologos believed in him; that this is the old Silver Diner location; that they have spent \$800,000 in renovation; that they are renovating the interior; that they have a Greek interior designer; that he will work 60-85 hours a week; that his brother in law will help with the business; that there are no changes to the application; that the first Double T Diner opened in 1959; that the current owners bought them in 1987; there are currently eight diners with seven owned by the Mr. Korologos

<u>Ioannis Korologos</u> stated that he is a resident of Ellicott City; that the hours are as stated that they have 145 seats; that they make donations to schools, churches and sports.

that the renovations have started; that the anticipate opening early summer; that he understands the responsibilities; that they offer typical American cuisine; that there are no changes to the application; that they will donate to the police department.

<u>Tao Li</u> stated that he is a resident of Frederick; that he is the owner of the restaurant; that he is a citizen; that he holds 85% of the stock; that the has a partner with 15%; that he has not been convicted of a felony; that he has not been charged with violation any gambling laws; that he does not have an interest in any other business with an alcoholic beverage license; that Quing Huang holds 15% of the stock; that he will work on the premises eight hours a day; that they have 192 seats in the restaurant; that there is a bar without any seats; that the restaurant is 5300 square feet.

Mr. Camacho moved to approve the request to change the number of seats on the applications, seconded by Ms. Kelsey and made unanimous by Mr. Bowman, Mr. Miles and Mr. Graham. Tao Li stated that the build out is expected to cost \$1.1 million; that they will have a full menu; that they will offer Southern Chinese cuisine; that Southern Chinese cuisine is spicy; that they will also offer Japanese food; that he previously owned a restaurant in Frederick; that he owned that restaurant for seven years; that he is opening this restaurant in College Park; that he anticipates his clientele being students and facility of the University of Maryland as well as the community; that he has read the rules and regulations; that he understands the rules and regulations; that a patron must be 21 to consume alcoholic beverages; he stated the five acceptable forms of identification; that the servers and bartenders will be alcohol awareness certified; that he will comply with the rules and regulations; that the hours on the application are correct for now; that he will donate to the police, fire department and students; that parking is available; that he anticipates opening in August or September.
