In the matter of **t/a Woodmore Wine and Spirits,** Class A, Beer, Wine and Liquor, Sureshwar, Inc., 2801 Campus Way North, Suite 306, Lanham, 20706 – Delivery Permit Request.

Lalit Patel stated that he is a resident of Lanham; that he is here for a delivery permit; that he had one before; that he had one since 2012; that he doesn't know what happened; that he was never told to renew; that he got a new license issued and it didn't have it listed on there; that he didn't see a notice or know it he needed to renew it; that they deliver to the neighborhood of Collington; that the old people over there need delivery; that they just get cheaper wines and that the delivery helps him to make money; that he wants to be able to service older people; that he gets orders by phone; that he takes the credit card number over the phone if they're paying by card; that 80% of them pay by check when they deliver; that he knows he needs info and to check their identification when he delivers; that they don't come in when they order for him to check their identification for the order; that he knows most of them by name; that he can tell they're older; that he doesn't get many new orders, maybe 1 or 2 times a weeks; that he will get their identification information before he delivers; that he only delivers to Collington; that it is a gated community; that one employee does the delivery; that he knows the person purchasing must be over the age of 21; that the community doesn't have many delivery orders per week; that he is aware he has a tax hold; that he understands he must settle the tax issue before the permit can be issued.

Ms. Kelsey moved to approve the request for a Delivery Permit, seconded by Mr. Miles and made unanimous by Mr. Bowman and Mr. Camacho.

In the matter of **t/a El Mexireno Restaurant,** Class B, Beer, Wine and Liquor, El Mexireno Restaurant, Inc., 5494 St. Barnabas Road, Oxon Hill, 20745 – Special Entertainment Permit Request.

Applicant is represented by Wesley Japp, Esquire.

Jesus Mejia stated that he is a resident of Lanham; that he is the 100% owner; that he has 15 years of experience in the restaurant field; that customers asked for music and karaoke so he applied for the permit; that he needs it to compete with the other restaurants in the area; that he added 8 video cameras; that he has plenty of commercial lighting; that he has private security and Prince George's Police Department off duty officers; that they will be inside and out; that there will be no dancing; that he does not have a Dance Hall Permit; that he had a Special Entertainment Permit, but he let it expire last year; that he didn't renew because of money. Corporal Cicale stated that she is a Corporal with the Prince George's County Police Department; that she met with the applicant today; that it is a small space; that it is a carryout atmosphere; that the security plan is adequate; that the hours are correct; that having the Special Entertainment Permit will change the hours of operation; that Mr. Mejia originally said he expected to have 30 people and later changed it to 70; that she wants to verify with his Use and Occupancy Permit to verify his maximum occupancy; that he has more than enough security for either number of people; that she asked Mr. Mejia why he has so much security, he said he wanted to err on the side of caution; that she wants to view his documents and make them a part of the record; that she will notify the Board once she reviews the Use and Occupancy and verifies the number of people allowed.

Ms. Kelsey moved to approve the request for a Special Entertainment Permit, seconded by Mr. Miles and made unanimous by Mr. Bowman and Mr. Camacho.

Ms. Kelsey moved to amend the hours of Operation for Friday and Saturday until 3:00 a.m., seconded by Mr. Miles and made unanimous by Mr. Bowman and Mr. Camacho.

In the matter of **t/a Phil's Bar & Grill,** Class B(R), Beer, Wine and Liquor, Phil's Bar and Grill, LLC, 10624 Baltimore Avenue, Beltsville, 20705 – Special Entertainment Permit Request.

Ahmed Singh stated that he is a resident of Silver Springs; that they are applying for a Special Entertainment Permit for the bar; that they completed the procedure; that they submitted their security plan; that they met with Corporal Cicale; that they showed her the restaurant, cameras and exits; that they have lighting in the parking lot, both the front and side.

Corporal Cicale stated that she is a Corporal with the Prince George's County Police Department; that she met with the applicants in late August; that the security plan is adequate; that the patrons are loyal; that they have had no calls for service to this location; that they the security is to be handled in house by employees and management; that she has no issues with it and that is how it is handled currently; that it is meant to enhance the dining experience.

Ms. Kelsey moved to approve the request for a Special Entertainment Permit, seconded by Mr. Miles and made unanimous by Mr. Bowman and Mr. Camacho.
