Commissioner Bridgwaters-Simms: At the Board of License Commissioners, we endeavor to be as efficient as possible in our virtual environment. Thank you for your patience. This is a public meeting subject to the Maryland Open Meetings Act so a truthful, transparent, open, and honest dialogue and record is required. As such, there are some formalities that will take place that may appear redundant but nonetheless are important and required to ensure compliance with the law.

Director Sheppard: During a typical hearing, there would be an exchange between the Board and the attorneys to exchange information as exhibits. Because this hearing is now virtual, we have implemented a 10-day rule to give those individuals here today, 10-days from today's date to add to the official record. I would ask that you email myself or the administrative staff of the BOLC. You may add information to the record long as it is information that has been discussed in this hearing.

PRELIMINARY MATTERS

1. Substitution of Corporate Officers application, t/a National Golf Club at Tantallon, Class C, GCC, Beer, Wine and Liquor, 300 St. Andrews Drive, Fort Washington, 20744, Mulugeta Tesfakiros to serve as Managing Member, Aster Haileselassie, Member, Sentayehue Abebaw Desta to serve as Member/Resident Agent instead of Timothy O'Brien, President/Secretary. Represented by Gregory Lee, Esquire.

Ms. Desta will be the resident agent holding twenty-five percent membership interest of DC Dynasty, LLC. She will be attending Alcohol Awareness training soon and the certificate will be submitted to the Board.

Mr. Lee asked the standard questions typically used to qualify the Substitution of Corporate Officers Application. The applicant was able to answer each question. **Commissioner Camacho** asked what the six acceptable forms of I.D. are, and the legal age to purchase and sell alcohol.

The applicant was initially unable to list the six forms of I.D., after pausing this case the applicant was able to answer each question.

Director Sheppard asked if anyone else is being added to the license as there were two names listed on the agenda.

Mr. Lee confirmed that the two licensees currently existing are Mr. Tesfakiros and Ms. Haileselassie. We are adding Ms. Desta to the license.

Commissioner Camacho makes a motion to approve the SCO for t/a National Golf Club at Tantallon, seconded by **Commissioner Norman**.

REGULAR SESSION

1. t/a Bistro 64, Gilda Mae Williams, Managing Member, Class B(R), Beer, Wine and Liquor, MMB Unlimited, LLC, 6494 Marlboro Pike, District Heights, 20747. — Suspension Hearing.

Attorney Richard Basile representing Kenneth Ndeh who holds eighty-four percent of MMB Unlimited LLC. **The Board allowed Mr. Basile to admit his appearance.**

Ms. Williams states that at the time of the violation she was out of the country. Her son Brian Williams is the manager and runs the daily operation. Mr. Williams had trouble notifying his mother of the incident.

Mr. Williams states he was aware that there should not be a DJ after nine' o clock, as the inspector was entering the establishment the DJ was breaking his equipment down.

Mr. Williams states the violation and late fee can be paid by this upcoming Friday, March 29, 2024.

Director Sheppard states that the Board of License Commissioners has no record of a majority stockholder, if there is anyone who needs to be added to the license, this information needs to be disclosed by March 29, 2024.

Commissioner Camacho makes a motion to hold the show cause in abeyance until Friday when the payment is made in full, and all management agreements for licensees be updated immediately, seconded by **Commissioner Norman.**

Licensees do not have an attorney, acknowledge their right to an attorney, and agree to move forward without representation.

Commissioner Camacho ensures that the licensees understand the importance of validating customer ID's, using his own vehicle and holding records for eighteen months. **Commissioner Smith** questions whether licensees know about any oppositions to this Delivery Permit as there were previous oppositions within the community.

Mr. Chin states they have resolved all community issues surrounding their business. Commissioner Norman requests to know the last date of inspection for t/a Central Avenue Liquors.

Mr. DeLoach states that the Board has not received any official notice for the opposition of this Delivery Permit.

Deputy Chief Inspector Mendoza shows the last record of inspection was on January 3, 2024, there were no issues found during the inspection.

Director Sheppard states we will need an amendment to the applicant's titles on the application.

An amendment has been made to the application to reflect that Temitope Popoola will serve as Managing-Member and Dean Eluma as Member.

Deputy Chief Mendoza gave a maps presentation.

Mr. Eluma states Myste Lounge is a small hookah establishment providing an environment for relaxation. The anticipated opening date is April, latest by May. There is no other establishment like it in the area. We have received approval from the zoning Board to open.

Commissioner Bridgwaters-Simms asked the standard questions typically used to qualify this type of license. Including what are the six acceptable forms of I.D., and the legal age to purchase and sell alcohol. Both applicants were able to answer each question.

There is no opposition present for this case.

Commissioner Camacho makes a motion to approve the Class D(on) license for t/a Myste Lounge, seconded by **Commissioner Sparkman**.

After Board vote, the motion carries.
