#### **CHARGES:**

Allegedly, the citizen that resides in 18 Sutton Court, Upper Marlboro MD 20774 owns a white dog that is left on the side patio and on the yard outside of the house for an extended period. The dog causes excessive noise and disturbance to their neighboring resident, Ms. Jalloh. This is a violation of Section 3-131 'Manner of Keeping Animals; Prohibition of Nuisances'; Section 3-132 'Public Nuisance Conditions'; Section 3-134 'Excessive noise by an animal prohibited'; Section 3-142 'Irresponsible Pet Owner'; Section 3-145 "Ferret, Dog, and Cat Licenses' of the Prince George's County Code.

This is a violation of Section 3-131 'Manner of Keeping Animals; Prohibition of Nuisances'; Section 3-132 'Public Nuisance Conditions'; Section 3-134 'Excessive noise by an animal prohibited'; Section 3-142 'Irresponsible Pet Owner'; Section 3-145 'Ferret, Dog, and Cat Licenses' of the Prince George's County Code.

# **CHARGES:**

Allegedly, on January 2, 2023, Ms. Phillips was walking her dog when she and her dog were attacked by Ms. Conception's dog "Chapo". Both Ms. Phillips and her dog were bitten in the incident. Ms. Phillips was treated at Washington Adventist Hospital and her dog was seen by Prince George's Animal Hospital. This is in violation of Section 3-131 (c) 'Manner of Keeping; Prohibition of Nuisances'; Section 3-132 'Public Nuisance Conditions'; Section 3-135 'Animal at large prohibited'; Section 3-142 'Irresponsible Pet Owner'; Section 3-145 'Ferret, dog, and cat license'; Section 3-182 'Potentially Dangerous Animals'; and Section 3-186 'Vaccination of dogs, cats, and ferrets.'

### **CHARGES:**

Allegedly on January 17, 2023, Ms. Davis's dog "Koji" was being walked by her boyfriend when a female, Rottweiler, "Roxie", was able to escape from its fenced yard and attack Ms. Davis's dog. The attack caused severe injury to "Koji" resulting in expensive medical care. This is in violation of Section 3-131 (c) 'Manner of Keeping; Prohibition of Nuisances'; Section 3-132 'Public Nuisance Conditions'; Section 3-135 'Animal at large prohibited'; Section 3-142 'Irresponsible Pet Owner'; Section 3-145 'Ferret, dog, cat license'; Section 3-182 'Potentially Dangerous Animals'; and Section 3-186 'Vaccination of dogs, cats, and ferrets'.

## No. 108-23 VA PRINCE GEORGE'S COUNTY, MD

v. MONAY JONES

#### **CHARGES:**

Allegedly on March 21, 2023, Ms. Simmons was walking her dog "Ghost" when they were attacked by a white and tan "Pitbull" type dog that resides at 2208 Connecticut Ave. Ms. Simmons was walking on the 6800 block of Flagstaff Street when the dog appeared and began attacking her dog. The attack resulted in severe injuries to Ms. Simmons' dog's genitals. The injuries were treated at a veterinary office. This is in violation of Section 3-131 (c) 'Manner of Keeping; Prohibition of Nuisances'; Section 3-132 'Public Nuisance Conditions'; Section 3-135 'Animal at large prohibited'; Section 3-142 "Irresponsible Pet Owner'; Section 3-

182 'Potentially Dangerous Animals'; and Section 3-186 'Vaccination of dogs, cats, and ferrets'.

## **CHARGES:**

Allegedly on March 31, 2023, three terrier mixed dogs; "Zeus", "Cookie", "Cream", were running at large and attacked Mr. Brown's dog "Isis", a female miniature schnauzer. The attack led to severe injuries that resulted in the dog being euthanized due to the degree of damage caused. The dogs were impounded as strays by Animal Services Division. After confirming ownership with Ms. Jackson on April 4, 2023, and discussing the incident that occurred. Ms. Jackson surrendered all 3 dogs to Animal Services Division. This is in violation of Section 3-131 (c) 'Manner of Keeping; Prohibition of Nuisances'; Section 3-132 'Public Nuisance Conditions'; Section 3-135 'Animal at large prohibited'; Section 3-142 'Irresponsible Pet Owner'; and Section 3-186 'Vaccination of dogs, cats and ferrets'.

## **GENERAL RULES**

Cases shall be called in the order in which they appear on the docket. The Commission may consider cases out of the order presented on the written docket, at the discretion of the Chairperson, to promote efficiency and as an accommodation to the parties involved.

All attempts will be made to allot time fairly to opposing parties and witnesses. However, all persons testifying under oath shall speak only after receiving recognition and consent of the Chairperson.

Hearings are open to the public. Verbal and physical disruptions from the public are prohibited. Members of the public are required to comply with rules, directives, and orders of the Commission.
