This is in violation of Section 3-131(c) 'Manner of Keeping Animals', Section 3-132 'Public Nuisance Conditions'; Section 3-135 'Animals at large prohibited'; Section 3-136 'Dangerous Animals'; Section 3-142 'Irresponsible Pet Owner', Section 3-182 'Potentially Dangerous Animals'; and Section 3-186 'Vaccination of dogs, cats, and ferrets.' of the Prince George's County Code
