I. Approval of Agenda

III. Consideration of Open Issues

1. 09-23: 10805 Blackpowder Court — Shirley Lathern

Continued non-compliance with county laws, operating without the required rental license.

RESCHEDULED TO MAY 25, 2023 per Respondent's request.

2. 10-23: 6600 Foxley Road — Douglas Roeser

Loud noise from heavy equipment and commercial vehicles, trash and debris, the cutting and removal of trees without a permit, property maintenance and permitting issues, and tenants with no U&O.

3. 11-23: 3100 Branch Avenue — Douglas Roeser

Illegal parties, food and alcohol sales, charging admission, trash and debris, loud noise and music, permitting and property maintenance issues, loitering, and a recent homicide on the property.

4. 12-23: 5102 Indian Head Highway — Douglas Roeser

Trash and debris, unauthorized signage, loitering, and other property maintenance and permitting issues

Trash and debris, unauthorized signage, loitering, and other property maintenance and permitting issues

6. <u>14-23: 5110 Indian Head Highway — Douglas Roeser</u>

The board unanimously voted to declare case 13-23, 5106 Indian Head Highway, a public and neighborhood nuisance; ordered to cease and desist all nuisance activities that constitute a nuisance, closure ordered for at least 6 months or until in compliance. The board also unanimously voted to declare case 14-23, 5110 Indian Head Highway, a public and neighborhood nuisance; ordered to cease and desist all nuisance activities that constitute a nuisance, closure ordered for at least 6 months or until in compliance. All other cases were rescheduled. The meeting was adjourned at 4:15 PM by Douglas Roeser.
