PRINCE GEORGE'S COUNTY DRAFT COUNTY FISCAL YEAR 2026 ANNUAL ACTION PLAN FOR HOUSING AND COMMUNITY DEVELOPMENT

The Prince George's County Draft Fiscal Year (FY) 2026 Annual Action Plan (AAP) for Housing and Community Development is now available for public comment for a period of thirty (30) days. The public comment period will end on April 11, 2025. The Annual Action Plan for Housing and Community Development is a comprehensive strategy that describes actions, activities, and programs that will take place during FY 2026 to address priority needs and specific objectives identified in the FY 2026–2030 Consolidated Plan. The AAP also serves as an application for the following Federal entitlement funds: Community Development Block Grant (CDBG) Program, HOME Investment Partnerships (HOME) Program, and the Emergency Solutions Grants (ESG) Program.

The FY 2026 AAP is based on the U.S. Department of Housing and Urban Development (HUD)'s Federal FY 2024 (County FY 2025) formula allocations with estimated entitlement allocations for each activity that may be proportionally adjusted to match the actual funding allocations upon notification from HUD. The estimated FY 2026 formula allocations for the County are: CDBG - \$5,291,711 plus \$533,109 in Program Income; HOME - \$2,187,892.87 plus \$997,197 in Program Income; and ESG - \$465,086 plus \$465,086 in Matching Funds.
