No. 117-24 VA CITY OF COLLEGE PARK, MD

v.

MARVIN BONILLA

CHARGES:

The City of College Park Animal Control is requesting a Dangerous Dog Hearing due to the dogs listed above allegedly running at large and attacking dog "Moogie" in the street on Edmonston RD on May 17th, 2024, and May 29th, 2024. This is in violation of Section 3-131, "Manner of Keeping Animals"; Section 3-135 "Animals at Large Prohibited"; Section 3-142 "Irresponsible Pet Owner"; Section 3-136 "Dangerous Animals"; Section 3-182 "Potentially Dangerous Animal"; and Section 3-145 "Ferret, dog, and cat licenses."

No. 127-24 VA CITY OF GREENBELT, MD

v.

KAWANNA VADEN

CHARGES:

Greenbelt Animal Control urgently requests a neglect/cruelty hearing. Allegedly on June 4, 2024, the Greenbelt Police Department responded to a call about four dogs at large at 6004 Springhill Dr, Apt 102 Greenbelt MD 20770. When the police officer showed up, a witness advised that they had reason to believe that the dogs had been abandoned for two months. Officers confirmed with the leasing office that the unit belonged to Lavonne Kawana Vaden, and they had reason to believe it had been abandoned due to the unit having no furniture and no one was home. All four dogs were impounded due to suspected neglect and abandonment. This is in violation of Section 3-131 (a) (1), "Manner of Keeping Animals- Proper Food"; Section 3-131 (a) (2), "Manner of Keeping Animals- Proper Water"; Section 3-131 (a) (7), "Manner of Keeping Animals- Proper Cleaning"; Section 3-131 (a) (12), "Manner of Keeping Animals- Proper Cleaning"; Section 3-142 "Irresponsible Pet Owner"; Section 3-145 "Ferret, dog, and cat licenses.";

Section 3-180 'Animal Cruelty and Neglect; prohibited; Section 3-186 'Vaccination of ferrets, dogs, and cats'.

No. 128-24 VA PRINCE GEORGE'S COUNTY, MD

v.

PRINCESS ORMSBY

CHARGES:

The Prince George's County Animal Services Division is requesting a Dangerous dog hearing for the above animal (s). Allegedly on July 4, 2024, Ms. Ormsby's dog "Diamond" was reported to have been running at large with another dog when "Diamond" attacked Mr. Lee's four-year-old son without provocation causing injuries that were treated at Children's National Hospital. This is in violation of Section 3-131 (c) 'Manner of Keeping Prohibition of Nuisances'; Section 3-132 'Public Nuisance Conditions'; Section 3-135 'Animals at Large Prohibited'; Section 3-136 'Dangerous Animals'; Section 3-142 'Irresponsible Pet Owner'; Section 3-182 'Potentially Dangerous Animal'; and Section 3-186 'Vaccination of dogs, cats, and ferrets.'

No. 11-23 VA CARL FRITSCH

v.

LOUIS MCCLAM & CYNTHIA MCCLAM

CHARGES:

Allegedly Mr. McClam and Mr. McClam are non-compliant with the orders of the Commission for Animal Control resulting from the hearing held on May 29, 2024. This is in violation of Section 3-115 'Violation Notices; Citations' of the Prince George's County Code.

No. 104- 24 VA SHALETA ROBINSON

v.

GUSTAVO MANZUR

CHARGES:

Allegedly, on June 15, 2024, Mr. Manzur's dog bit Ms. Robinson's son on their left, pinky finger. This is in violation of Section 3-131(c) 'Manner of Keeping Animals', Section 3-132 'Public Nuisance Conditions'; Section 3-135 'Animals at large prohibited'; Section 3-136 'Dangerous Animals'; Section 3-142 'Irresponsible Pet Owner'; Section 3-182 'Potentially Dangerous Animals'; and Section 3-186 'Vaccination of dogs, cats, and ferrets.' of the Prince George's County Code.

No. 129- 24 VA DONADIN PALUCHO

v.

TYMOTHE GALLION

CHARGES:

Allegedly, on July 5, 2024, Mr. Palucho was walking his small dog on a leash when they were both viciously attacked by Mr. Gallion's Pitbull. This is in violation of Section 3-131(c) 'Manner of Keeping Animals', Section 3-132 'Public Nuisance Conditions'; Section 3-135 'Animals at large prohibited'; Section 3-136 'Dangerous Animals'; Section 3-142 'Irresponsible Pet Owner'; Section 3-182 'Potentially Dangerous Animals'; Section 3-185.01 'Pitbull Terriers'; and Section 3-186 'Vaccination of dogs, cats, and ferrets.' of the Prince George's County Code.

GENERAL RULES

Cases shall be called in the order in which they appear on the docket. The Commission may consider cases out of the order presented on the written docket, at the discretion of the Chairperson, to promote efficiency and as an accommodation to the parties involved.

All attempts will be made to allot time fairly to opposing parties and witnesses. However, all persons testifying under oath shall speak only after receiving recognition and consent of the Chairperson.

Hearings are open to the public. Verbal and physical disruptions from the public are prohibited. Members of the public are required to comply with rules, directives, and orders of the Commission.
