CHARGES:

Allegedly Ms. Genievski’s dog is causing a public nuisance by virtue of excessive barking and running at large. This is causing unreasonable annoyance, disturbance, or discomfort to neighbors or others near the premises where the animal is kept or harbored. This is a violation of Section 3-131 'Manner of Keeping; Prohibition of Nuisances'; Section 3-132 'Public Nuisance Conditions'; Section 3-135 'Animals at large prohibited'; Section 3-142 'Irresponsible Pet Owner'; Section 3-182 'Potentially Dangerous Animals';

CHARGES:

Allegedly, on June 17, 2024, at 10:30pm Mr. Brito’s large, dark brown/black, Pitbull type dog had attacked Mrs. Herrera’s father-in-law. Mrs. Herrera also witnessed Mr. Brito’s dog outside, unleashed, and unsupervised in April of 2024. This is in violation of Section 3-131(c) 'Manner of Keeping Animals', Section 3-132 'Public Nuisance Conditions'; Section 3-135 'Animals at large prohibited'; Section 3-136 'Dangerous Animals'; Section 3-142 'Irresponsible Pet Owner', Section 3-145 'Ferret, dog, and cat licenses', Section 3-182 'Potentially Dangerous Animals'; and Section 3-186 'Vaccination of dogs, cats, and ferrets.' of the Prince George's County Code.

CHARGES:

Allegedly, on April 14, 2024, Ms. Gomez went outside to check on her flowers when she noticed Ms. Herrera's tan and white, female, Pitbull type dog, outside and unleashed. When Ms. Herrera's dog noticed Ms. Gomez outside, the dog attacked Ms. Gomez' left leg and she had to be taken to the hospital. Ms. Gomez stated Ms. Herrera's dog has tried to attack her and her dog on multiple occasions and that on a separate incident her dog was also attacked by Ms. Herrera's dog. This is in violation of Section 3-131 'Manner of Keeping Animals', Section 3-132 'Public Nuisance Conditions'; Section 3-135 'Animals at large prohibited'; Section 3-136 'Dangerous Animals'; Section 3-142 'Irresponsible Pet Owner', Section 3-145 'Ferret, dog, and cat licenses', Section 3-182 'Potentially Dangerous Animals'; Section 3-185.01 'Pit Bull Terriers'; and Section 3-186 'Vaccination of dogs, cats, and ferrets.' of the Prince George's County Code.
