## 3. <u>03-24: 601 Autumn Grove Court — Shirley Lathern</u>

Non-compliance with previously issued NAB Order Case 38-23, property being rented without proper permitting/licensing, interior work done without proper permitting or final inspection of the work (no correction attempted), continued advertisement to rent property, disturbing the neighborhood

#### **Decisions**

Each case is deliberated in closed session. The board unanimously voted to declare case **55-23**, **6417 Elliot Place**, a public and neighborhood nuisance; ordered to cease and desist all nuisance activities that constitute a nuisance, immediate compliance ordered.
