# 1. 27-23: 3411 Kidder Road — Shirley Lathern

Walking dog without a leash & does not clean dog defecation from around the area, verbally aggressive to neighbors, property damage

#### 2. <u>25-23</u>: <u>6617 Valley Park Road — Shirley Lathern</u>

Gun fire, loitering, loud noise & music, trash & debris, safety concerns by surrounding residents, congested streets due to large gatherings, damage to surrounding neighbor's property, property maintenance issues, hostile/aggressive occupants

#### 3. 17-23: 4701 Saint Barnabas Road — Shirley Lathern

Trash & debris, No U&O permit, display of illegal signs, illegal pennants, banners & similar circus or carnival type attractions

Heavy equipment, commercial vehicles, loud noise, cutting & removing trees without proper permitting, trash & debris, other property maintenance & permitting issues

# 6. <u>28-23: 5308 62<sup>nd</sup> Avenue — Shirley Lathern</u>

Gun fire, public drinking, excessive loitering, loud parties & an overdose complaint, terrified residents, damage to surrounding properties

#### **Decisions**

Each case is deliberated in closed session. The board unanimously voted to declare case 27-23, 3411 Kidder Road, a public and neighborhood nuisance; ordered to cease and desist all nuisance activities that constitute a nuisance. The board unanimously voted to declare case 25-23, 6617 Valley Park Road, a public and neighborhood nuisance; ordered to cease and desist all nuisance activities that constitute a nuisance. The board also unanimously voted to declare case 28-23, 5308 62<sup>nd</sup> Avenue, a public and neighborhood nuisance; ordered to cease and desist all nuisance activities that constitute a nuisance. All other cases were rescheduled/postponed to a later date by DPIE. The meeting was adjourned at approximately 4:15 PM by Shirley Lathern.
