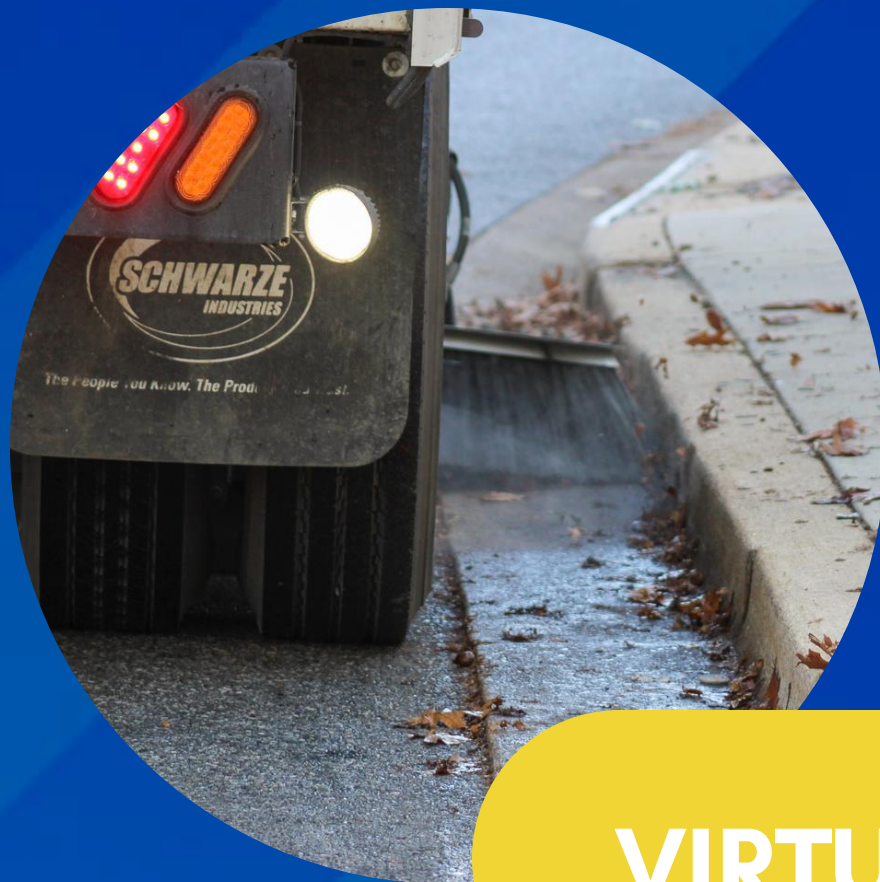

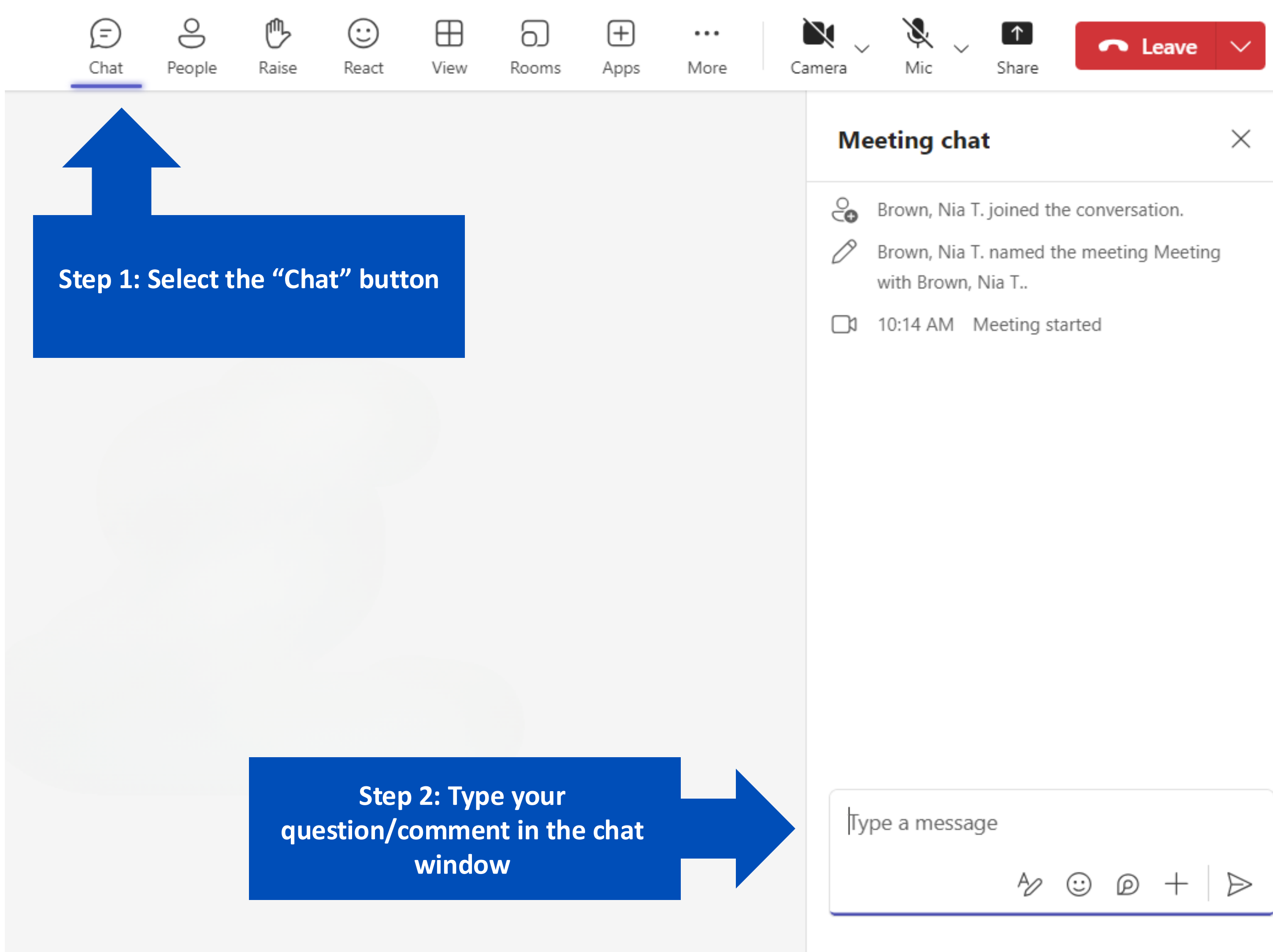

County Executive's Beautification Proud Priority Initiative

County Executive Angela Alsobrooks has prioritized aggressively addressing the litter problem in Prince George's County through a variety of programs and initiatives. The Department of Public Works and Transportation's (DPW&T) Residential Street Sweeping Program is the newest addition to her Beautification Proud Priority. It will significantly reduce the amount of litter and debris along residential roadways and improve our neighborhoods.





What is **Street Sweeping** & Why is Our County Implementing This Service?

DPW&T will offer Countywide Residential Street Sweeping for the first time in Prince George's County! This exciting new service will reduce litter in the gutter pans and along residential roadways that contribute to litter buildup and potentially lead to pollutants in our ecosystem. This program will be implemented in two phases.





How Important Is Street Sweeping According to Data?

- The 18-week Litter Blitz in Fall 2022 revealed the need to develop an effective litter abatement strategy throughout the County. A total of 925 tons of trash was collected during the Litter Blitz.
- The Department has developed the Residential Street Sweeping Program to support ongoing litter abatement initiatives in the County.



Improving **Water Quality** and Our **Environment**

- Nitrogen and phosphorous found in curbside litter threatens the County's water integrity and worsens the quality of the Potomac, Chesapeake Bay, and other bodies of water.
- Roadside litter and toxins on County streets adversely impact drainage and can potentially seep into storm drains.
- Street Sweeping removes debris and grime from residential curb lines which aids in minimizing the amount of dirt and pollutants that are tracked into homes.





Enhancing Roadway Safety

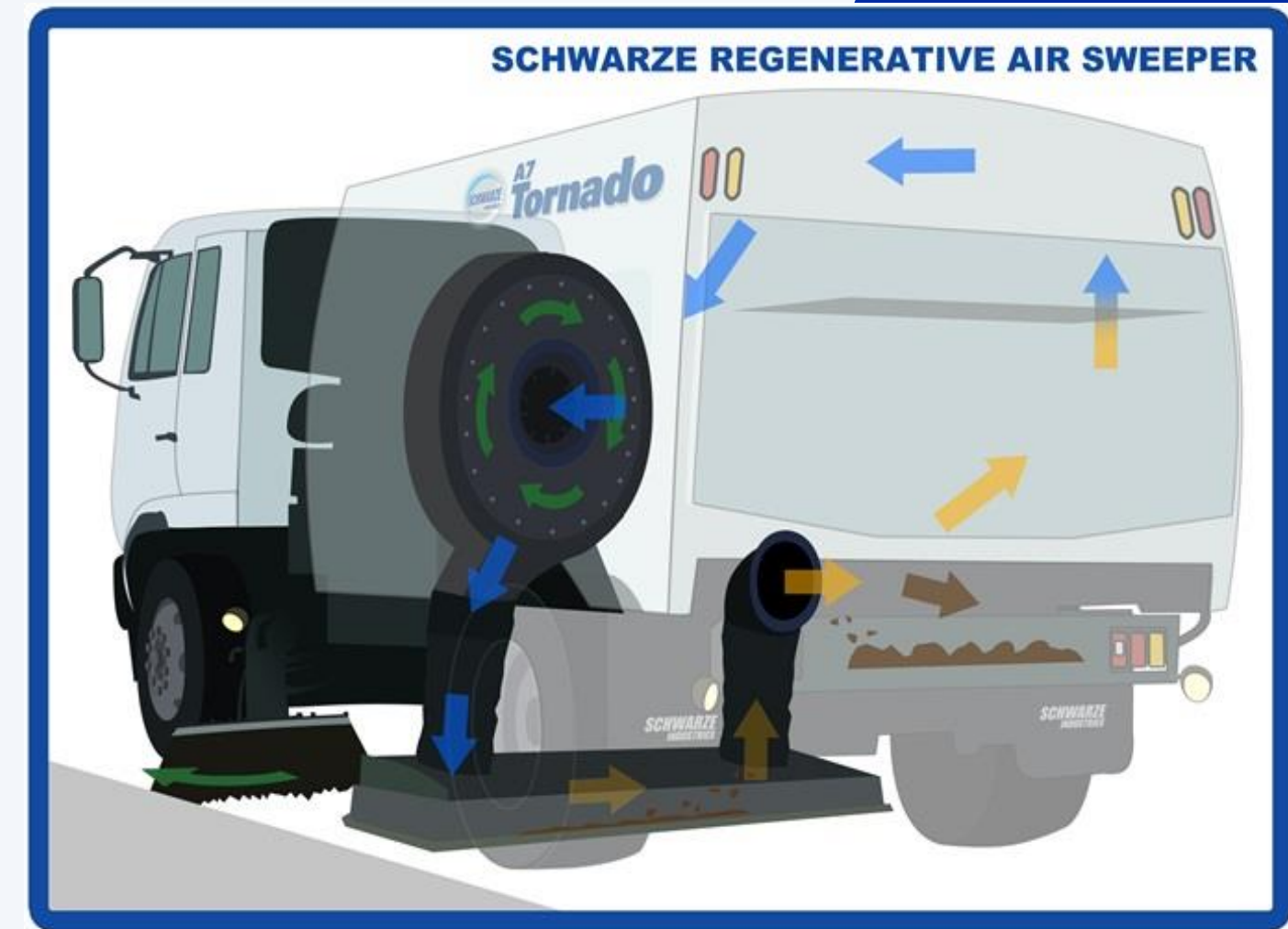
- Excessive amounts of dirt and litter can negatively impact driver and pedestrian experiences, leading to higher roadway incidents.
- Street sweeping assists with mitigating the risk of roadway incidents and keeps streets clear of obstacles and other road impediments.
- By treating our neighborhoods with care and intent, areas become more desirable. This leads to attracting more visitors, businesses, and tourists, ultimately resulting in long-term economic growth for the County.



New Sweeper Models used for Operations

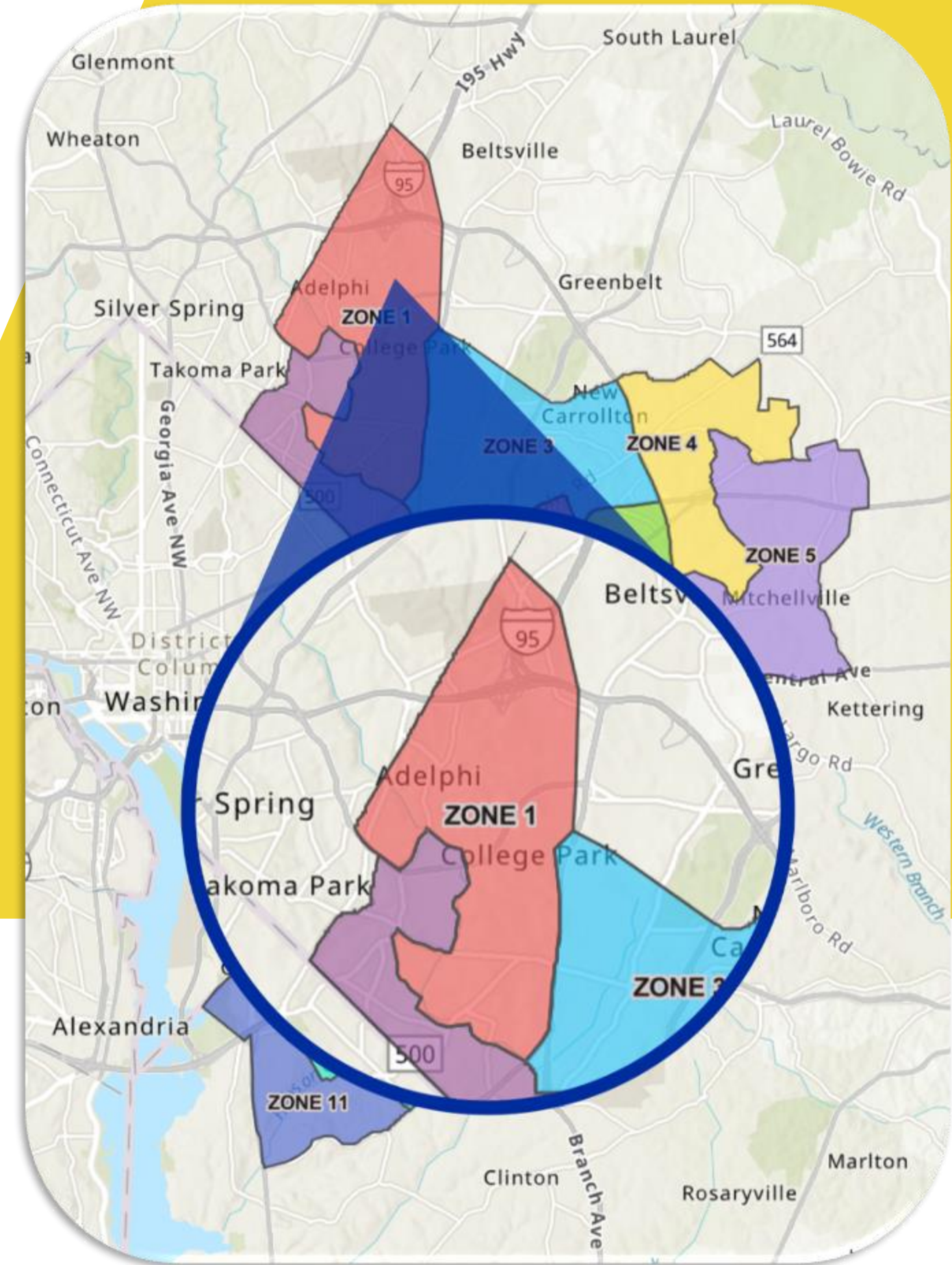
Phase	Sweepers	Total Curb Miles
Phase I	3 Sweepers	717 Miles
Phase II (County-wide)	5 sweepers	1,572 Miles

- These new sweepers are Regenerative Air sweepers, designed to be more powerful than broom or vacuum sweepers.
- These more advanced sweepers collect debris and smaller materials such as residual roadway salt, nitrogen, and phosphorous.



Operational Overview

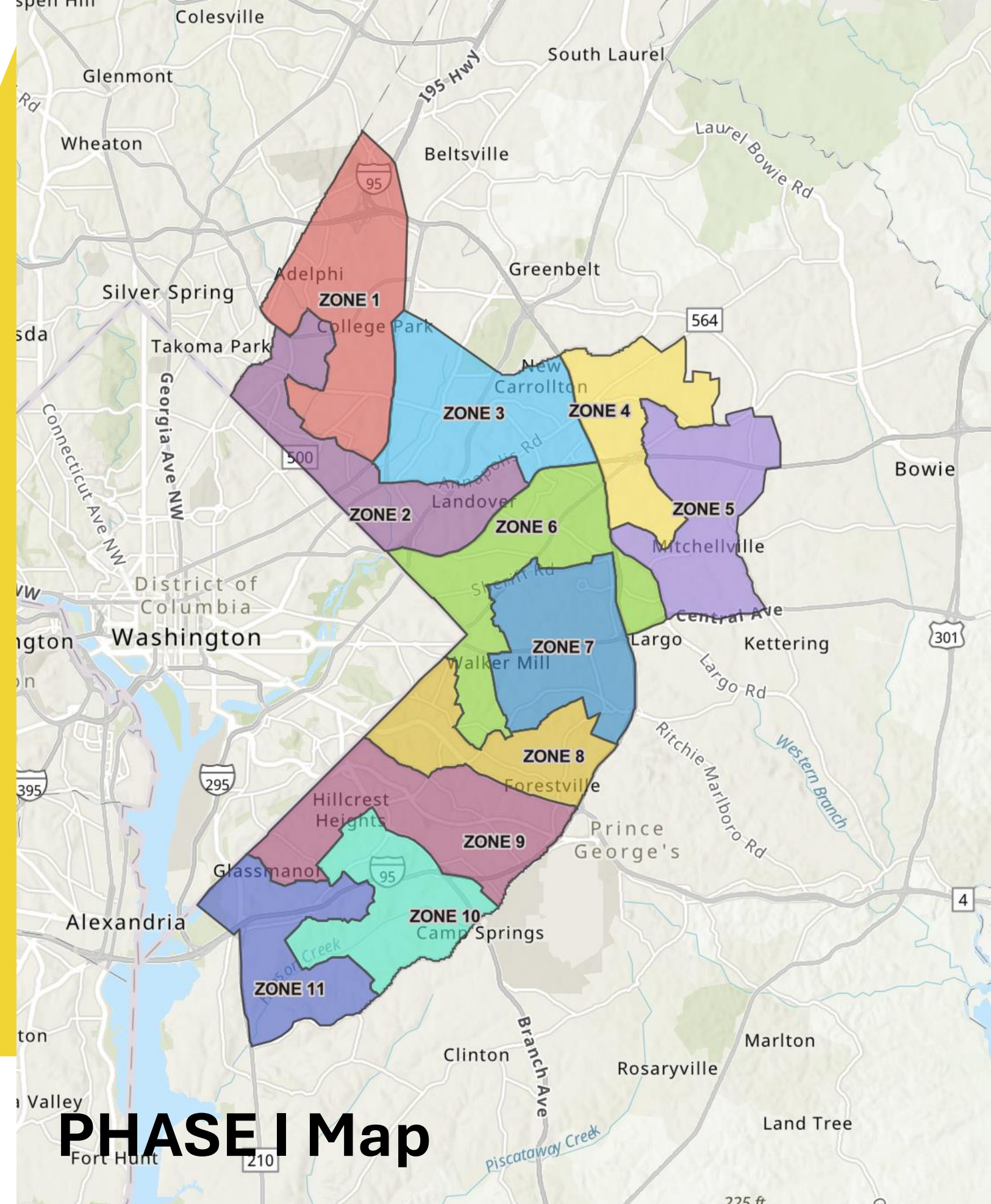
- Residential Street Sweeping will be offered in two phases.
 - Phase I will begin in late Summer 2024.
 - Phase II will begin in Spring 2025.
- Each Phase will have Zones that are made up of specific residential roadways, known as Sweeping Areas.
- How were Phase I Areas selected?
 - Equity Emphasis Areas (EEA)
 - Data results from the litter, mowing, and sweeping blitz identified heavily littered areas.





Phase I

- Starts September 3, 2024.
- Includes 11 Zones and 43 sweeping areas.
- Will be done every 5 weeks using 3 sweeper trucks.
- We will sweep approximately 717 curb miles each month.

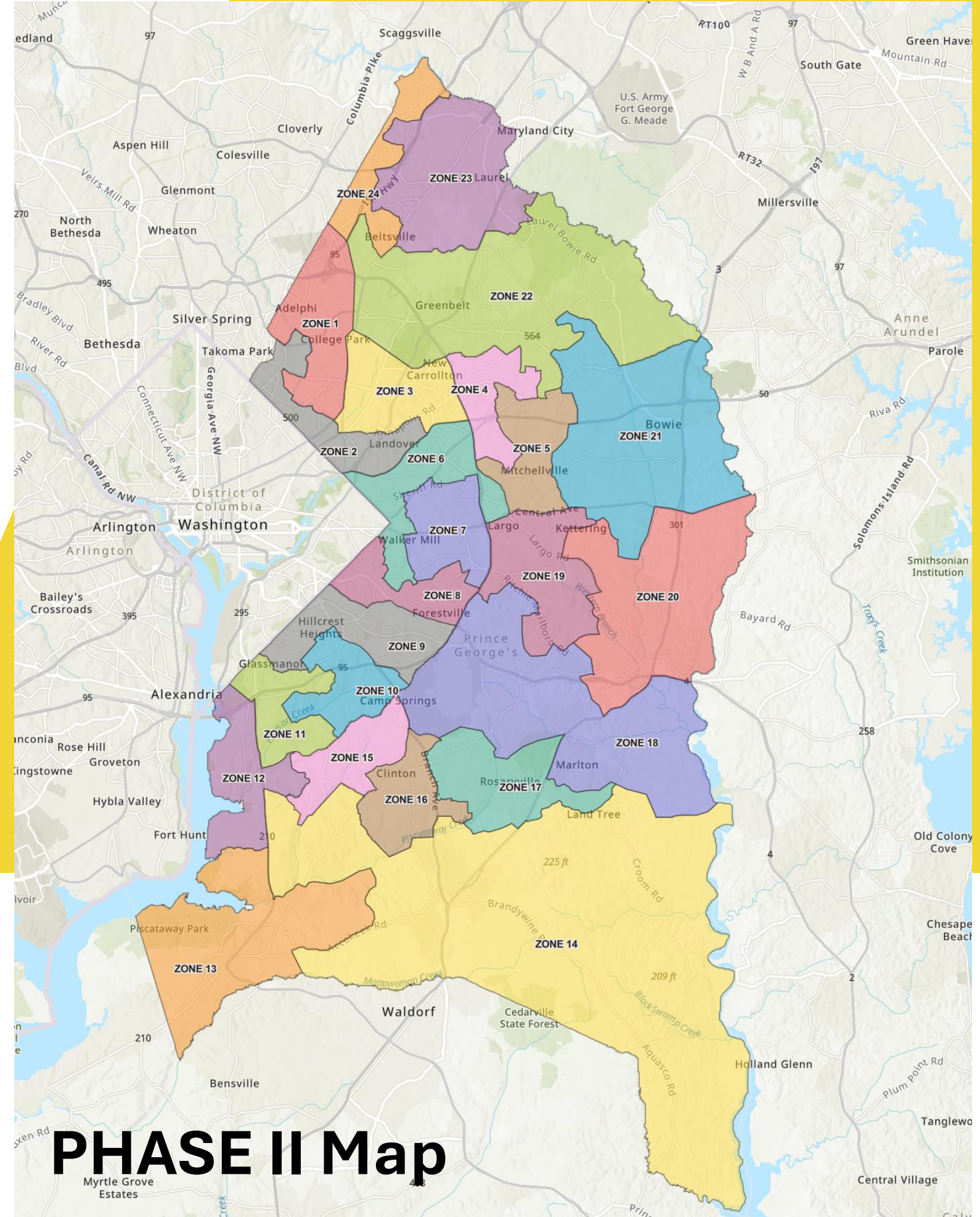


PHASE I Map



Phase II

- Starts Spring 2025.
- Includes 24 Zones and 95 sweeping areas. *(Incorporating all of Phase I and the remaining areas in the County).*
- Will be done every 5 weeks utilizing 5 sweeper trucks.
- We will sweep approximately 1,572 curb-miles of roadway per month.
- Beginning in calendar year 2025, DPW&T will implement annual residential street sweeping from mid-March to mid-October.

- There are a total of 24 Sweeping Zones that will cover the entire County.
 - **Phase I** will include 11 Zones
 - **Phase II** will include 24 Zones *(Incorporating all of Phase I and the remaining areas in the County)*
- In each Phase, Zones will be swept on a 5-week rotation.
- There are approximately four Sweeping Areas in each Zone.
- Use our interactive map and/or schedule calendar to determine what zone and sweeping area your road is in.



How To Find Your Zone

Interactive Online Map (Online) – Enter your address to find your Zone and sweeping schedule.

Finding Your Zone with the Interactive Online Map

- Step 1: Visit MyPGC.US/Sweep
- Step 2: Scroll to “Resource Guide”
- Step 3: Select “Interactive Map”
- Step 4: Once redirected, type your address in the upper left-hand corner text box.
- Don't forget - if your address falls outside of the colored areas on the map, you will be included in Phase II.



Understanding Your Sweeping Schedule

- Looking at this street sign: This resident would be in Zone 1.
- Therefore, their sweeping schedule is on Mondays: September 17, 2024, and October 7, 2024.
- If sweeping day falls on a holiday, the sweep day will jump to a make-up day.
- You can check out the signs installed in Zone 5: Lake Arbor Way, Chantilly Ln., and Forbes Blvd.
