This is in violation of Section 3-131 'Manner of Keeping Animals', Section 3-132 'Public Nuisance Conditions'; Section 3-135 'Animals at large prohibited'; Section 3-142 'Irresponsible Pet Owner', Section 3-182 'Potentially Dangerous Animals' of the Prince George's County Code.
