INTRODUCTION

On February 17th and 18th, 2021, One Source Environmental, LLC (OSE) performed a visual inspection for Universal Hazardous Waste Materials at the referenced site. The work was performed prior to planned demolition activities at the site.

METHODOLOGY

The inspection was performed by Dharam Kissoondath who has completed HAZWOPER training in accordance with 29 CFR 1910.120. Representative machine, light fixtures, signs, and other potential hazards were visually assessed and inventoried during the inspection.

FINDINGS

The following potential environmental hazardous materials were identified in the building that will require special disposal handling prior to demolition activities:

- Freon Containing Air Conditioning Units and Refrigerator
- Chemical Containing Fire Extinguishers and 5 Gallon Buckets of Maintenance Items
- Mercury Containing Thermostat Switches
- Possible Oil Containing Heating Units
- Battery and Mercury Containing Exit and Emergency Lights
- Asbestos Containing Materials (ACM)
- Lead-based Paint (LBP) and Lead Containing Components
- Possible Biological Hazards from Human/Animal Excrement and Dead Rodents

CONCLUSIONS AND RECOMMENDATIONS

Any environmental hazardous waste containing materials should be reused for their intended purpose, recycled, or should be properly disposed of in a hazardous waste landfill. A certified Hazardous Waste Hauler should determine proper disposal of any of the above referenced items.

Respiratory protection should be donned at all times when working in the building.



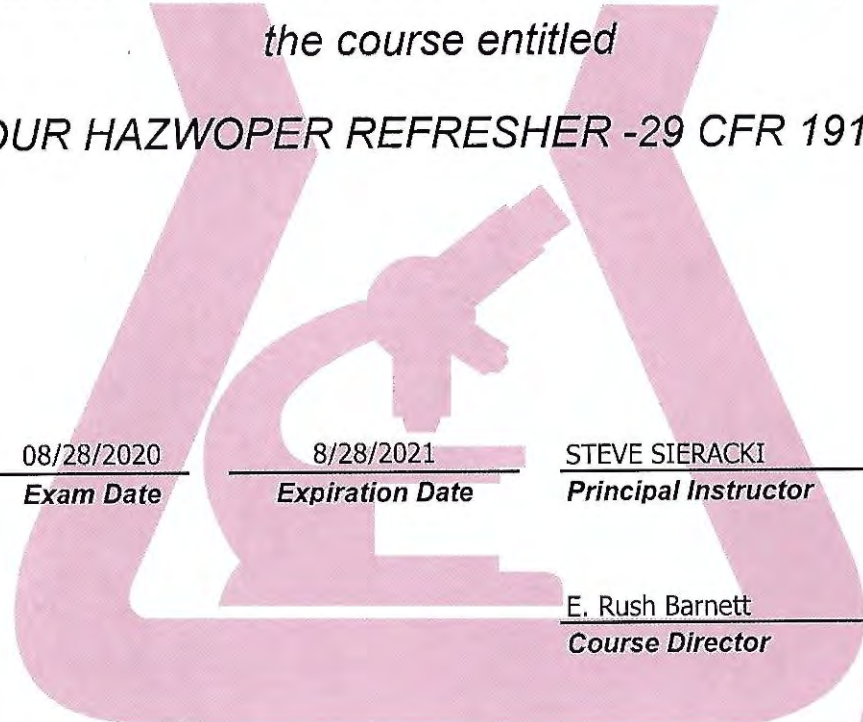
